SECOND AMENDMENT TO DECLARATION OF RESTRICTIONS

NOW, THEREFORE, know all men by these presents, that the Declarant does hereby amend the Declaration as follows:

1. The first sentence of Article V, Section (13) is deleted in its entirety and the following is substituted therefor:

No vegetable or similar non-flower gardens may be maintained in the front yard of any Lot or in side yards of any Lot closer to the front line of that Lot than the rear face of the dwelling on said Lot.

The Declaration shall hereinafter be deemed to be the Declaration as amended by this Second Amendment.
