The meeting was called to order by Janet Taylor. Reading of the minutes of the previous meeting were waived. A written copy of the Treasurer's report was accepted.

Old Business:

- Barricade A copy of the letter received from John Viola was reviewed. The letter indicated that he would replace the "jersey barricades" with two large concrete planters. The board agreed that at the present time, this is our best, most viable option. Janet will contact John and set a deadline of November 1st, 2004. Janet and Dave also agreed to keep Ron Siminson, V.P. Norwegian Woods Civic Association, informed.
