The Timber Farms Civic Association General Meeting on October 15, 2019 was held as part of the T.F.C.A. / T.F.M.C. Combined General Meeting at Thurgood Marshall Elementary School. The Treasurer's Report, as of 10/15/2019, was also in the Agenda / Handout package. In summary:

The Halloween Parade / Costume Contest will be held on Sat, Oct 26th and will start at 3:45 pm.

The next order of business was nominations for the 2 open positions on the T.F.C.A. Board for two-year terms 2020 – 2021: Vice-President and Treasurer. Dave Tackett took nominations for Vice-President: Linda Olds nominated Dave Frampton and Elaine Little seconded the nomination. Next, Dave Frampton took nominations for Treasurer: Elaine Little nominated Bob Oakes and Dave Tackett seconded the nomination. Elections for these two positions will be held at the next T.F.C.A. meeting on Tues, November 19th.

It was decided to hold off on New Business until later so that the T.F.M.C. portion, which had to hold elections, could begin. Once the T.F.M.C. voting got underway, T.F.C.A. got back to New Business.

Under New Business, a resident brought up the use of maps during the Garage Sale, wondering if they are really needed. Other residents reported street lights flickering at Post Oak & Anthony Drive and also on Anthony Drive; Timber Farms can report it, as can individual residents. A resident asked about an email regarding a neighborhood newspaper; this is not the one T.F.C.A. puts out.
