
## **Announcements**

## When Kids Ride Motor Scooters, Mini Bikes, Jr. Motorcycles, Mini Corvette, and All-Terrain Vehicles

The Maintenance Association and the Civic Association have been plagued with

calls protesting the use of these "junior sized motorized vehicles." In a very easy investigation, SENATE BILL NO. 234 was found. It is a new law, and police are eager to enforce it. Parents, please note, our roadways are state owned, and the open space is privately owned by the maintenance association (meaning children need written consent to ride on those grassy grounds).

Currently: ALL MOPEDS, MOTOR SCOOTERS, ALL-TERRAIN, MINI CORVETTES OR JR. NINJA DIRT BIKES ARE FORBIDDEN IN ALL AREAS OF OPEN SPACE, ROADWAYS AND PRIVATELY OWNED AREAS (like your neighbor's lawn). Yes we are watching:

- The all-terrain vehicle from East Silverfox has damaged grounds and concrete sidewalk at the north corner of Timber Farms and Woodland Road.
- The green Ninja mini bike consistently runs stop signs and has been clocked at a speed of 45 mph. (At least he wears a helmet, unlike all others.)
- The mini corvette used the driveway of 628 Timber Wood Blvd. and rode across the lawn to gain access to the open space on the north end of Timber Wood and Woodland.

If you need to report any motorized activity in our neighborhood, call the non-emergency number, 573-2800. It would be helpful to know the address of the offending party. ## Delaware's African-American Schools of the 1920's-30's

It seems education is always being reformed. Back in 1915 a federal study ranked Delaware schools 39th in 48 states. Much discussion and the interruptions of World War I delayed Delaware's reaction, but finally in 1919 Delaware passed a new school code that included rebuilding of the state's one-room schools for white students. Although some of the tax money collected from white taxpayers would improve African-American schools, they would not be rebuilt in accordance with new architectural designs and the Progressive Era's nationwide social reform. A school was considered a highly specialized building, and its design was a key issue aimed to improve overall education.

Pierre Samuel du Pont took a personal concern for the African-American students in all of the small rural areas of the state. In 1919, he stepped down from the helm of the family run company and devoted his time and two million dollars of his own money to the rebuilding of these 80 schools.

His motivation and ideas were not unique, since similar initiatives were taking place in 14 of the southern states. Rosenwald, an early partner of the Sears & Roebuck company, helped finance about 5,300 African-American schools there.

In 1926, Mr. du Pont predicted the success of the nation's educational system to the success of his Delaware Initiative. He invited other states to do the same. In 1938, a new federal study showed Delaware had advanced to eighth place in 48 states.

Several of these schools are still here today as evidence of this progressive effort by Mr. du Pont. The closest two are Iron Hill Museum, located on Old Baltimore Pike about 1.5 miles west of Rt. 896. The other is being refurbished, after it burned years ago, with the guided efforts of grown students of the school, in the town of Christiana.

Donations of money and/or building materials are being accepted by the *Afro-American Historical Society of DE*, located in Wilmington, 571-9300, for the rebuilding and preservation of these schools in Delaware.

## Bear, Delaware! What a Name

Although years ago bears probably roamed these parts of Delaware, it was not why this area is named Bear, Delaware. It was named for a local tavern, *Bear Tavern*, that existed until 1845 when the building burned down.

Generals Washington, Lafayette and others used this tavern when traveling to and from Chesapeake Highway. The actual location is said to be four miles west of Rt. 13 on the north side of Rt. 40.

### **An Update From Nellie Manlove**

Calvarese Farms (Rt. 40 and Walther Rd) lots of prep work is near completion. The first home permit for this project should issue in the near future. Gemcraft Homes bought the project and will be doing all the building, but the site contractor may have hit some poor soil that will require some minor design changes.

In front of it, the builder has subdivided Rt. 40 frontage for Governor's Square additions. Office buildings are being built with no tenant contracts as yet. Krispy Kreme is the only known store at this time.

The restaurant/store pad site on Rt. 40 next to Season's pizza and in front of Leasure School still has no one under contract. He started this prep work so his sunset law would not apply (grandfathered under old county codes).

Christina Town center is once again on hold. A court found the builder to be guilty of site violations for storm drainage and other roadway issues. Jo-Ann's Fabrics still plans to open August 6th.

Royal Farms on corner of Old Baltimore Pike and Silver Lake Rd. allowed their application to expire. If they reapply, they will have to go through the same process of approvals once again.
