With news that the developer wishes to build the remaining 56 homes in the community, and thus have the existing restriction that limits the number of homes in the community to 225 lifted, it's been a busy Winter and Spring. Two community meetings were held (March 8, 2006 and April 5, 2006) to allow the developer's attorney to present information on the history and intent of the developer, hear the concerns of the community, and solicit comments, suggestions, and ideas to try to minimize impact to current residents and potentially improve the value of the community. By the time this newsletter is out, residents should have already received a packet and ballot to try to determine a community consensus with regard to lifting the restriction. While the consensus is not a guarantee of anything, it could have a large impact on what happens moving forward.

Vandalism has also been an issue in the neighborhood. The message regarding vandalism or suspicious activity is to be alert, look out for one another, and report everything – even if it's a non-emergency.

On a positive note, our neighbor and County Councilman Dave Tackett, and County Executive Chris Coons, recently unveiled the forthcoming plans for the Glasgow Regional Park. The plans really look great!

With the approaching summer season, I just want to remind everyone about neighborhood courtesy. The speed limit is 25 MPH in residential neighborhoods and New Castle Council laws require curbing of pets. Please treat others with the same courtesy and respect you desire from them.

A NOTE FROM COUNCILMAN TACKETT ON THE LIFTING OF THE DEED RESTRICTION FOR PHASE III

Dear Neighbors:

As you are aware, our community has been approached by a developer who would like to have the deed restriction lifted that was placed on the plan years ago, in favor of DeIDOT, to allow him to build the last phase of homes. DeIDOT has now written a letter supporting the lifting of the deed restriction they had initially supported.

This community has had two meetings thus far with the attorney for the developer where all sorts of issues and concerns were raised.

By now you should have received a ballot from the Civic Association designed to get the feeling of the community as to whether the community supports the lifting, with restrictions that were formulated by the community (the Civic has the list), or if the community does not want the additional homes built. The Civic has agreed to gather all the votes and speak in one voice as to what they would like to see happen next.

Our biggest problem is that the restriction is a DelDOT restriction and now they have stated it is no longer needed. New Castle County has not and will not issue any opinions about lifting the restriction until the formal process has started with us. And that process should start soon.

Please make sure you fill out the ballot and return it as soon as you get it so the Civic can draft the letter to the attorney and I will have some clear direction as to how to proceed.

What's in a name? Like Old Baltimore Pike.

Old Baltimore Pike infers that it connects, somehow, to Baltimore. It actually was never built to do so. The road's history began when settlers on Welsh tract requested a road be built from the head of the Elk River to the Christina Bridge, in 1723. At the time, only a small Indian trail that led east and west over the south side of Iron Hill existed.

Welsh Tract was a parcel of land surrounding the Welsh Tract Primitive Baptist Church, a log meeting house built in 1703. The tract was part of 30,000 acres deeded to three Welshmen: David Evans, William Davis, and William Willis. It included Iron Hill's southern slopes, and reached over to its northern slopes, now part of Interstate I-95. At one time, Welsh Tract Road passed behind the church and continued up and over Iron Hill. Traces of the abandoned road, worn down by iron ore wagons, can still be seen to the southeast of the church.

The new road would be important in connecting two extremely busy shipping ports in its day. The grain mills along the creeks and tributaries in Delaware and Cecil Country needed to transport products more easily. Dayett Mills being only one large manufacturing mill on this route.

The resulting road was known as Old Post Road. The money needed for the repairs was hard to come by so it was incorporated and renamed, in 1813, as the Elk and Christiana Turnpike. It took until April of 1817 to be built. The turnpike ran from the town of Christiana to the Maryland line, seven miles. Tolls were collected at Cooch's Bridge and near the intersection of where Smalley's Dam Road once met up with Old Baltimore Pike. After the establishment of the New Castle and Frenchtown Railroad, the turnpike was less used, and so, in 1838 it reverted back to a public road.

The road as we know it has also been changed over time. In 1938, the road was straightened to bypass Cooch's Bridge. The old route that traveled through Cooch's Bridge remains to this day and is called Old Cooch's Bridge Road. It travels south to Glasgow (once Aikentown) past what once was known as Purgatory Swamp.

When I-95 was completed in 1963 the section of road from Old Baltimore Pike to I-95 was permanently closed. The closed section still exists after sixty dormant years. It contains three historic bridges and the remains of cable guardrails. It parallels the feeder road for Dayett Mills, crosses the southern end of Purgatory Swamp. At the North side of I-95 the road remains open and again enters at Welsh Tract Road.

The road holds history too. Delaware is the only state in which all the allied troops went down a single path, Old Baltimore Pike -- the road from Christiana DE to Elkton MD. While camped along this road the U.S. Continental regiments waited for a month's salary before proceeding. They had demanded this while passing through Philadelphia, and it was supplied in part from silver, which the Continental Congress borrowed from Rochambeau's treasury wagons.

Development has lost many opportunities to find remnants of old clothing and militia, wagon parts, and evidence of Lenape Indians before all that. As I travel, to and fro, I often wonder what treasures I could find in some of the now state owned/controlled land between 896 and Rt. 72.
