#### More notes from the neighborhood:

It's hard to believe we've been residents of Timber Farms for over 15 years. My wife and I settled on our house in the Summer of '92, and like many of the people of the fairly new neighborhood, were eager to meet new friends and neighbors.

The Maintenance Organization did not yet exist. Maintenance was essentially the responsibility of the builder, but there was not yet a "voice" in the neighborhood for the community as a whole. Many people were interested in the well being and future of the community, and in the Fall of 1992 (at least as I recall), the first community civic meeting was held. There was a large turnout and even multiple candidates vying for officer positions.

The first President was Jim Ferguson, who was instrumental in getting the Civic Association going, as he spent much time and effort working with Karen Venezky (our previous County Council representative, prior to the change of Council boundaries.) The first Vice-President was Dan Stone (a great guy, even though he's a Redskins fan... although us Eagle fans have had considerably better times since then). The first Treasurer was Chuck Vincelette (yes...a fellow Eagles fan), and the first Secretary was Carol Soltis (although I'm not sure if I've correctly remembered her last name). Of those folks, only the Vincelettes are still residents of the neighborhood.

## **NOTES FROM COUNCILMAN TACKETT**

Dear Residents of Timber Farms,

I hope you had a long, relaxing, and most of all, safe summer. I know the first day of school came too quickly at my house and like most years we were not totally ready.

Since our community has had several code related issues, I wanted to take a minute and give you some info on our code department and tell you about a great new tool. Our code department has a total of nine code officers, seven of these are certified property maintenance and housing inspectors and two are rental code inspectors. If you own a rental or live in a rental, it must be registered with New Castle County. Failure to do so will result in hefty fines.

So far this year for code related complaints, the cases are up dramatically with an estimated 9,456 cases projected for the year. This number has sent a red flag to the county and we must find ways to get the number back down. So we have started sending a courtesy letter for many first notices. The county is also conducting more show cause hearings. We are bringing in the property owners for a meeting. We are looking at on-spot ticketing and the possibility of starting a county court to help deal with the issues.

One of the best ideas thus far is a new way to enter code complaints. This is now online at: http://www.co.new-castle.de.us/LandUse/home/webpage35.asp. You can enter a complaint anytime and the computer will send back to you a case number that will allow you to monitor the situation. You will not be able to get specifics, but you will be able to check on the status of the complaint.

Use this new online reporting system to report any property maintenance issues. If you do use this new feature, I would like to know what you thought of it, how easy it was to use, and if you would change anything.

Some other differences were that Timberwood Boulevard ended at Silver Fox, since that phase was just in the process of being built, and neither The Oaks, Norwegian Woods, nor Westover Woods existed yet. The Open Space by the pond was essentially a depot for construction garbage and debris, including used brick, siding, lumber, appliances, and numerous, but friendly wild cats and kittens. The most recent phase by way of Post Oak Lane was just field and trees, and was often the romping ground of snakes, deer, and even a few red foxes.

### **MESSAGE FROM JOHN VIOLA**

This past legislative session, Governor Ruth Ann Minner signed legislation that will make Delaware more attractive to businesses by lowering workers' compensation insurance premiums. Senate Bill 1 is expected to save employers between 15 and 21 percent of current costs.

Workers, insurers, and employers will benefit from this bill because it streamlines payments to workers while still allowing insurers to maintain their existing rights to contest employer's claims. Under the new payment system, doctors could receive up to 90 percent of the most common charges for medical services while surgery charges by hospitals could be cut by 15 percent.

Specifically, Senate Bill 1 creates a medical care fee schedule to outline treatment charges and will develop health care practice guidelines or medical protocols for the injury treatment. In addition, a 17-member panel including nine doctors appointed by the governor will be established to create the fee schedules. The legislation also includes provisions governing lawyers' fees in an effort to control legal costs while ensuring that injured workers understand the fees and requirements aimed at speeding up payments to doctors.

This legislation is the result of many groups working together, including labor, medical, and insurance, and I am proud to have supported it. Our state was in desperate need of workers' compensation reform.
