Important Information Regarding Pets:

Effective January 1, 2010, New Castle County assumed responsibility of dog licensing. This was mandated by the State of Delaware. Dog owners have until March 1, 2010 to get a county license. Failure to license your dog can result in fines.

Our snow removal contractor has asked us to remind all residents to have all vehicles off of the roads when snow is forecasted. This provides easier access to our roads and will eliminate the possibility of damage to your vehicle.

It is important to keep all storm water drains clear of snow and ice. If you have a storm water drain in the vicinity of your home, please take a few minutes to clear the drain so that it can accept the melting snow. Clearing the storm drain of any obstructions will provide proper drainage. With drainage restored there is a minimum amount of standing water to re-freeze resulting in safer roadways.

Special Olympics Delaware

Special Olympics is an international movement which, through year-round sports training and competition in the Olympic tradition, gives people with intellectual disability the chance to strengthen their character, develop their physical skills, display their talents and fulfill their human potential.

Special Olympics Delaware (SODE) is a not-for-profit, volunteer organization that serves as the motivational framework within which sports training and competition opportunities take place for those individuals eligible for the program who reside in Delaware.

SODE offers athletes an opportunity to participate in 17 sports - aquatics, athletics (track & field), alpine skiing, basketball, bocce, bowling, cross-country skiing, cycling, equestrian, golf, powerlifting, long distance running, roller skating, soccer, softball, tennis and volleyball.

There is no cost to join Special Olympics. All uniforms, equipment and competition costs are covered by SODE. Most training is offered at no cost to the athlete; however, some sports, such as bowling, require specialized training facilities and may require some type of fee due to facility expense. Many local programs conduct fundraisers to offset these costs.

The mission of Special Olympics is to provide year-round sports training and athletic competition in a variety of Olympic-type sports for children two years of age and older and adults with intellectual disability (or other significant learning or vocational problems), giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and participate in a sharing of gifts, skills and friendship with their families, other Special Olympics athletes and the community.
