Speed bumps on Timber Wood Boulevard? Our residents on Timber Wood Boulevard regularly report speeding along that road, and several of them have requested that we consider installing speed bumps. Speed bumps could be installed by DelDOT at no expense to our community on the portion of Timber Wood Boulevard that extends between the ends of Woodland Road. The DelDOT procedure for installing speed bumps includes preliminary monitoring to gauge traffic speeds and a survey of all residents that regularly use the roadway where speed bumps would be installed. Speed bumps will only be installed if speeding is regularly detected and a majority of the surveyed residents are in favor of them. The Civic Association will be sending out a preliminary survey over the next few months to assess the level of neighborhood support for speed bumps on Timber Wood Boulevard only. Please respond promptly to this short survey which you will receive by regular mail.

#### **Glasgow Park Skate Park Information**

I wanted to provide you with an update on the skate park that New Castle County will be constructing. It is an approximately 18,500 square foot skate park plaza and bowl facility. This park has been the subject of multi-phase construction for both active and passive recreation use. This skate facility will provide recreational opportunities for an underserved youth population.

The facility will include a plaza like setting that will feature steps, radial benches, rollers, manual pads and railings. It is designed so that the skaters have a safe environment and the participants are not performing their sport among automobiles and pedestrians in shopping centers and parking lots. Landscaping and grass turf will add to the ambience of the area.

I feel that this new skate park will be a place for our children to enjoy the fresh air and wide open spaces and receive exercise. I am proud to have helped spearhead this project. I am looking forward to leading the way for future projects at Glasgow Regional Park.

#### **MAINTENANCE NEWS**

With the winter season quickly approaching it will soon be snow season. It is important to keep the roadway clear of parked cars to allow access for the snow removal contractor.

Please keep in mind that snow removal is a two step process. Depending on the amount of snow forecasted, will depend on how many first step visits the contractor will perform.

The first step visit will open up the development to allow access to Old Baltimore Pike. After the storm has subsided, step two begins, he will return to provide removal from curb to curb. The curb to curb process will depend on the intensity of the storm and the accumulated inches.

Last year many residents complained that they had to clean out their driveways more than once during the major storm. I realize duplicated work is not appreciated, however I do not know of any other way to address this situation.

Also, during a snow storm the installation of vertical delineators placed in the front yard at the curb can help the operator's placement of the plow. This operation can minimize the damage caused by the snow plow on your lawn. The delineators can be made of inexpensive ¾ inch PVC pipe.


