LETTER FROM OUR PRESIDENT

I hope everyone enjoys the upcoming holidays as 2012 approaches. Here are three items of neighborhood interest that I want to bring to your attention:

Speed hump survey – You recently received a two-page survey that was sent to all Timber Farms residents by regular mail. The purpose of this survey is to help the Civic Association board learn about our residents' preferences regarding the possible installation of speed humps in our neighborhood in an attempt to reduce speeding. We've designed the survey to be very short, easy to complete, and we've included a postage-paid return envelope. The survey is one page long, includes details about the DelDOT process for speed control measure planning, and includes a second page with information designed to help you make a more informed decision. I ask each of you to take just a few minutes to consider your views on speed humps and to complete the survey and mail it back to us no later than December 31, 2011. It's important that we learn your views, even if you have no strong opinion, since the board will consider the results of this survey when deciding on potential future requests for DelDOT speed control measure evaluations. Note that this survey is for planning purposes only. If we decide to request a DelDOT evaluation, and DelDOT recommends installation of speed humps, you will have an opportunity to vote on a specific DelDOT plan prior to its implementation. Any speed control measures, if installed, would be paid for with state funds.

Holiday home decorating contest – Judging for our annual holiday home decorating contest will take place on Friday, December 23, starting at 6pm.

Board member elections - I would like to thank our vice president, Dave Frampton, and our treasurer, Bob Oakes for their service as board members over the past two years, and I want to congratulate both of them on their November 9th reelection for another two-year term.

MAINTENANCE NEWS

Last month at a scheduled maintenance and civic meeting, the agenda called for the election of officers for the maintenance board.

At the meeting, it was brought to the floor that our current election process is not following the by-laws of our Maintenance Corporation. Also some members were asking for a copy of the by-laws of our Maintenance Corporation. With an unclear understanding of the election process according to the by-laws, the maintenance board decided to postpone the election. The election of officers was tabled until we could become more familiar with the election process according to the bi-laws. After locating a copy of our by-laws, we had our web site designer post the document on our web site for all residents to view.

I recommended that our attorney review our by-laws, especially the voting process, and make a recommendation on how the balloting should be conducted. After his review the attorney made comments and recommendations to be followed in the election process. It is necessary to have 141 votes for the board election either in person or by proxy. Proxies are good for one year. If the needed votes are not obtained at the election meeting, additional meetings will have to be held until the quorum of 141 votes is met.

The Timber Farms by-laws also state that the annual Timber Farms Maintenance Assessments are due by February 1. The Maintenance Corporation was turned over to the Timber Farms Community from the builder (Forest Creek-Capano) in 1999. Since then B & C Consulting, New Castle County and last year the Maintenance Corporation has mailed out the bills on March 1st with the due date of April 30th.

The maintenance board will reschedule the membership meeting as soon as schedules permit. The meeting will be for the elections of officers.


