LETTER FROM OUR PRESIDENT

Spring is here, and the weather is finally getting warmer. I hope you have a chance to spend some time outdoors. If you haven't already done so, visit Glasgow Park on Route 40 near Route 896. The park has a beautiful 2.6 mile walking loop, a great playground, basketball and tennis courts, and several nice picnic pavilions.

All planned modifications at our entrance on Old Baltimore Pike (installation of a protected left-turn arrow and expansion of the center island) are now complete. I want to thank Senator Bryan Townsend for pursuing these changes to help make vehicle traffic at our entrance safer. Please let us know if you note any unsafe motorists at the entrance, including the date and time.

As many of you know, we experienced a voltage surge on our electricity service lines on April 20th. This is the third significant surge that we have experienced over the last nine years. This surge caused quite a bit of equipment damage in many residents' homes, particularly to more sensitive electronics like computers, televisions, and large appliances. Delmarva Power has denied all claims for compensation that were submitted as a result of this surge. We provided details about this incident to our local legislators. Senator Bryan Townsend has indicated that he will be pursuing some legislative measures over the next few years to shift the burden for these types of incidents back to Delmarva Power, since there a number of cost-effective measures that they could be taking to protect customer equipment.

Note that, although several of your home circuit breakers may trip as a result of a voltage surge, those breakers are really only designed to protect against excessive current from equipment faults or short circuits inside your home. To protect your home from damage from future voltage surges, consider installing a whole-house surge protector near your circuit breaker panel. These devices are available for less than \$100. Also consider installing high-quality surge protectors at the wall outlets serving the most sensitive equipment, like computers and televisions.

Information from Councilman Tackett

Legislation Update: Tax Penalty abatement

Councilman David L. Tackett introduced an Ordinance to abate tax penalties if property owners pay their back taxes in full by May 29th 2015. On Tuesday April 28th at the Council meeting the ordinance passed. The Councilman is aware that economic times are difficult and many of our citizens need a little help to stay afloat. This ordinance provides a much needed program that will give a financial break to a number of residents of New Castle County while we are on the road to recovery. The County's Assessment department can answer any specific questions you have or you can contact my office and we will be happy to discuss the details with you 395-8371.

County Executive Thomas Gordon stated, "Councilman Tackett's legislation is fair and takes into account some of the economic challenges our county residents have faced for some time. His ordinance attempts to acknowledge and forgive taxpayers who come forward and pay taxes by May 29th. It is noble."

There are several Tax exemptions and services available for those who are over 65 or disabled. You can contact Councilman Tackett's office and request a booklet with those benefits plus others that are available to Delawareans who are 50+. 302-395-8371

"Tax exemption applications are available for 2015. New Castle County is happy to offer up to \$32,000 in property tax exemptions to eligible residents age 65 or older. Letter from Senator Bryan Townsend

Dear Timber Farms Residents,

The April electricity surge that damaged so much property in Timber Farms homes is but one of several in recent years. It is unfortunate that Delmarva Power has denied all homeowners' claims for reimbursement, up and down Old Baltimore Pike. In response, I will undertake efforts in 2015 (likely into 2016) to determine why this area of our senatorial district has experienced several surges in recent years. Over that same timetable, I also will pursue changes to Delaware laws or regulations that make it less likely for a future event to damage so many homeowners' property and leave those homeowners on the hook. To put it differently: I believe there are reasonable-cost steps Delmarva could take to protect its ratepayers and their property, and I believe Delmarva should take those steps.

In other neighborhood-damage news, I have been contacted by Timber Farms residents about new tire marks near the entranceway, left by DelDOT contractors who were working on the repaving of

Walther Road. I relayed the message to DelDOT and asked that the tire marks be addressed ASAP and that DelDOT contractors pay greater care whenever in Timber Farms.

In this short space, I cannot do justice to the very important legislative developments poised for 2015 and 2016, especially around Delaware's revenue sources. I welcome the opportunity to meet with interested Timber Farms residents in the coming


