Timber Farms has both a Maintenance Corporation and a Civic Association. All residents are members of the Maintenance Corporation and are required to pay annual dues, which were \$165 for 2015. The Maintenance Corporation is responsible for maintaining our common open space areas, snow removal, and enforcing our deed restrictions. If you want to add or modify a fence, deck or shed, or make significant changes to your home's exterior, contact the Maintenance Association (TimberFarmsMaint@aol.com) for approval. You can get copies of our deed restrictions and Maintenance Corporation by-laws and budgets on our web site (www.timberfarmscivic.org) by following the Maintenance Corporation link.

Membership in our Civic Association is voluntary, with annual dues just \$25 per household this year. The Civic Association organizes neighborhood social events, publishes a quarterly newsletter, maintains the web site, and coordinates email communication with residents. Currently, 70% of our residents are Civic Assocation members. If you aren't a member, please consider joining us.

Highlights of the October 21, 2015 Timber Farms Maintenance Corporation Meeting

The meeting was called to order and the highlights of the meeting were as follows.

Solar Energy Vote Results: As many of you are aware the Timber Farms Maintenance Corporation mailed to each home a voting ballot. This ballot was sent out for consideration of the proposed amendment for allowing installation of solar panels. The results of the vote were 153 in favor of removing the deed restriction and 45 opposing the

removal. The removal of the restriction will now allow solar panels to be installed. Our attorney will process the change to our deed and file the change with the Recorder of Deeds.

Snow Removal Contract: Our snow removal contract has been signed for the 2015-2016 season. Included in the snow budget are allowances for salting. This season we have included salt to be applied to our major intersections and entrance areas. We will have salt applied upon direction from the board, since it is not reimbursed from the state and it does add a measurable cost to the operation.

Election of Officers: The Timber Farms Maintenance Corporation held its election of officers during the October membership meeting. The results of the two-year term are as follows:

Projects in our Area

In the 26th District, DelDOT is planning several key projects that will improve our daily commutes and make it easier to get around in our area. I will keep you updated as these projects progress. (Note: Projects listed in bold are new or previously delayed projects that are moving ahead as a result of infrastructure funding legislation passed this year.)

- US 40 widening, Salem Church Road to Walther Road
- SR 72/Old Baltimore Pike intersection safety improvements
- SR 273/Chapman Road intersection improvements
- Old Baltimore Pike/Salem Church Road intersection safety improvements

If you aren't sure, call the company to confirm or call 911 to report any suspicious activity.

Package Pirates: The New Castle County Police would like to warn residents about the risk of having packages delivered to an empty home.

The holiday season is right around the corner and many residents have started online shopping to beat the shopping mall rush. Unfortunately, "Package Pirates" are on the look-out for an easy grab.

Last year, the New Castle County Police received a total of 98 complaints regarding the theft of packages. Nearly half of the reports were received in the months of November and December. Recently, there have been reports of suspicious vehicles following delivery trucks. We have a few tips to keep "Package Pirates" and Grinches from taking your packages.

- Opt to require a signature for all package deliveries. Residents should review the delivery options at "check-out" for there is an option to leave specific delivery instructions for the delivery company on where to leave packages.
- Consider sending the package to a family member or trusted neighbor who is home during the day to accept the delivery.
- Use the "pick-up at store" option for merchandise or pick-up packages at a local UPS or FedEx location.
- Sign-up for e-mail or text message alerts from UPS or FedEx. These alerts will notify customers of when packages were delivered.


