#### INFORMATION FROM SENATOR TOWNSEND

Dear Neighbors,

I hope this newsletter finds you well as we transition from Summer to Fall!

The summer months involved plenty of road construction in our area — bringing some headaches and frustrations in the short-term, but safer roads and commutes in the long-term. The 2018 repairs on Rt. 72 and on Walther Road, and the completion of the redesign of Old Baltimore Pike and Rt. 72, will be followed in 2019 by the redesign of Old Baltimore Pike and Salem Church Road (both intersections) for smoother and safer traffic flow. Stay tuned for news of a Spring 2019 DelDOT town hall; I've asked DelDOT to present specific plans for OBP/SCR and receive final community feedback about proposed timing/ scope for road closures, which would play an important role in determining how long the project will run.

Thank you for your patience with these and other projects. Please never hesitate to contact me with questions or concerns about individual projects, or any other issue or idea that interests you. Not only is the most enjoyable part of being a legislator

having the chance to talk with you about how our government could and should operate, but it's also the best way to ensure our government operates well.

#### **INFORMATION FROM REP. JOHN VIOLA**

The General Assembly ended session in the early morning of July 1st. One of my proudest moments this session was the passage of legislation I sponsored along with Sen. Townsend, creating the "Green Alert Program." The Green Alert Program will help law enforcement officers and members of our communities in locating missing members of the armed forces, including veterans, who have a physical or mental health condition related to their service. This issue was brought to us by a concerned constituent, and I'm happy to have seen this through.

This legislative session, we tackled many important issues, all while passing a balanced budget that maintains vital state services, invests in infrastructure, and increases programs for children, low-income families, correctional officers, seniors and people dealing with addiction.

As I mentioned earlier in the year, we will have a "DMV on the Go" onsite at the Timber Farms Community Picnic on September 8th. This is a wonderful program that brings many of the major DMV driver and vehicle services directly to the community. You will be able to get a new driver's license, change your address, renew your vehicle registration, obtain a handicap placard and purchase an E-ZPass transponder. Please be prepared with all the required documentation for your transaction. You can visit www.dmv.de.gov for a list of the required documents and vital information.

#### TIMBER FARMS MAINTENANCE CORPORATION

As I mentioned in May's Newsletter regarding the final paving of our roads and turning over of the open space; we are still in the correction phase. I have been in recent conversation with LC Homes regarding the on- going punch list that needs to be corrected before we can complete the final turnover. I fully expected this process to be completed 3 months ago, however re-grading, removing large dead trees and establishing grass to prevent water runoff had to be established before New Castle County would accept the open space. We are now at an expected date of September for the turnover and the paving.

At our last Board Meeting the Board approved upgrading our entrance camera. The improvements will improve the memory and software performance of the camera system. The work will begin the week of August 13th and should take one day to complete.




