### INFORMATION FROM COUNCILMAN TACKETT

Dear Timber Farms Residents

Every so often a resident in the district will reach out to me about an issue they are experiencing with a contractor they have hired. Many times there is not a lot that New Castle County can do because this is a private contract the homeowner has entered into. Taking the precautions below will go a long way to protect you.

Planning a Home Improvement Project?

A home improvement is the intent to construct, alter, repair, move, demolish, or change occupancy or use of a single-family dwelling or its accessory structures.

If you are a homeowner considering a home improvement, it pays to know your rights before you enter into a contract and your available remedies should something go wrong.

To assist you, here are some best practices that should be taken into consideration.

**CONTRACTOR SELECTION:** Homeowners can avoid many problems by selecting qualified contractors. While there are no guarantees, risks are reduced if the homeowner makes certain that the contractor has all of the required licenses with the State of Delaware and New Castle County. All individuals and businesses that provide construction and building improvement services are required to obtain a New Castle County contractor license in addition to the State of Delaware business license. Those contractors performing work requiring a permit or utility trade work need a contractor license with permit endorsement. You can verify contractors online at [www.nccde.org/license](http://www.nccde.org/license).

**CONTRACTOR'S INFORMATION:** The contract should contain the name, address, and New Castle County contractor's license number. If the contractor intends to use subcontractors to complete any work, then the contract should contain the name and license number of each subcontractor.

**DATES:** A home improvement contract should contain the approximate dates when work will begin and when it will be completed.

**CONTRACT LANGUAGE:** Your first right as a consumer is to know what you're agreeing to; so the written contract should be legible and clearly state the specifics of the job and the materials to be used. The contract should describe each document that it incorporates, including construction plans and materials list, and it should be signed by each party to the agreement. Remember the contract is a legally binding document so it is important to understand what is being signed. Lastly, the homeowner should receive a signed copy of the contract prior to the work starting. The contract should include all warranties and guarantees from the contractor, subcontractor, and material suppliers.

**DEPOSIT AND PAYMENT:** As with any contract the agrees-upon price of the home improvement should be clearly stated, and no payment should be made until all parties sign the contract. It is not uncommon for a down payment representing costs of material and other early costs (e.g: design fees, permit fees, etc.) to be paid prior to work commencing. Beyond the deposit, additional payment terms should seek to break the job down into as many discrete components as is reasonable, and to keep the costs of materials and labor for that component. Homeowners shouldn't get into a position where they make final payment prior to the completion of work.

## INFORMATION FROM SENATOR TOWNSEND

Dear Neighbors,

I hope the summer is coming to safe close for you and your families, and that we can gather as a community soon. Two local updates:

(1) the four-way stop configuration has been completed at Timber Wood Blvd, Woodland Rd, and W. Hummock Lane. DelDOT approved this measure, which was supported by the documented speeding along Timber Wood Blvd and the exceptionally close vote by the neighborhood not to approve speed humps. Thank you for those who take the extra seconds to drive safely in our community.

(2) State Rep. Madinah Wilson-Anton and I have been in touch with the owner/director of The Little Caboose Child Care & Learning Center, regarding families from TLC engaging in dangerous maneuvers at the entrance to our neighborhood. The owner was extremely responsive and has encouraged her families to be mindful of traffic laws and safe maneuvering. If issues continue, we will examine possible enforcement measures.

Please never hesitate to let me know how I might be of assistance, and please be safe as the pandemic continues.

## **TIMBER FARMS MAINTENANCE CORPORATION**

We are happy to report that this year's maintenance fee has been paid by 99.3% of our residents. This is an exceptional percentage and great accomplishment, due in no small measure to our treasurer, Bob Oakes, who keeps carefully track of payments and sends out reminders and warnings to those who have not paid so far, and we hope to reach 100% compliance soon.

Some residents have sent us complaints regarding the geese that have made our neighborhood their home. It seems that their number increases every year. They love bodies of water and grassy areas, something our development offers them. Please also note that Canada geese may be protected under the provisions of the Migratory Bird Treaty Act of 1918.

Residents have also informed us that a retention pond in our development showed unusually high water levels as a result of heavy rains and slow drainage. Our County Council member, Dave Tackett, is in contact with County employees who will try to find out what could be the cause of the problem.

Remember that prior to construction, fences, sheds, and additions such as decks, approval from the Timber Farms Maintenance Architectural Review Committee is required. Have a nice rest of your summer and please obey the new stop signs on Timber Wood Blvd.


